## Why should I buy plan b CRISIS RESPONSE?

plan b CRISIS RESPONSE provides you with 24/7 access throughout your journey to one of the worlds leading security consultant teams. The security consultants are on hand to provide immediate assistance, support and advice in the event of a crisis.

The level and nature of the services will depend on the circumstances and can include (but is not limited to):

- Mobilisation and deployment of response consultants to advise on extreme incidents.
- 24/7 point of contact to report emergencies and get security and safety advice from duty managers;
- Coordination of security resources;
- Liaison with 3rd parties where applicable;
- Monitoring and telephone advice throughout the Crisis ;

Crisis Consultant Services will be provided for up to 30 days (10 days in respect of terrorism). The cost of providing these services up to USD250,000 is covered at no additional charge to you, and the Consultant Service Provider will arrange for your approved Extra Expenses to be reimbursed.

## Who should buy plan b CRISIS RESPONSE?

Anyone travelling to conflict zones, disturbed areas, areas that are politically unstable and anywhere that there is a threat of terrorism and violent crime. There are no age limits (children can be covered with an accompanying adult who resides at the same address) or country restrictions.

## What is a Crisis ?

A Crisis is any decisive, unstable or crucial time resulting from unforeseen

- Act of Terrorism which directly affects a Protected Person's safety
- Violent Crime
- Wrongful Detention or Kidnapping
- Blackmail and Extortion
- Political Threat
- Disappearance
- Hijack

which has directly caused or has the potential to cause serious bodily harm, detention or death of a Protected Person.

## What Extra Expenses can be reimbursed?

Additional costs incurred by the Consultant Service Provider (or by a Protected Person acting on their direct instructions) will be reimbursed up to USD15,000. This can include:

- Fees and expenses of security guards temporarily retained solely and directly for the purpose of protecting Protected Person(s) located in the country where a Crisis has occurred.
- Emergency political evacuation costs;
- Legal expenses;
- Fees and expenses of an independent interpreter;
- Costs of relocation travel and accommodation;
- Fees for emergency medical care incurred within twelve months of the Covered Crisis.

## What is the Minimum and Maximum Length of Cover?

The minimum length of cover is 5 days, the maximum is 365 days.

## What does plan b CRISIS RESPONSE Cost?

Daily access fees start at just USD3.28 subject to a 10 day minimum access fee
